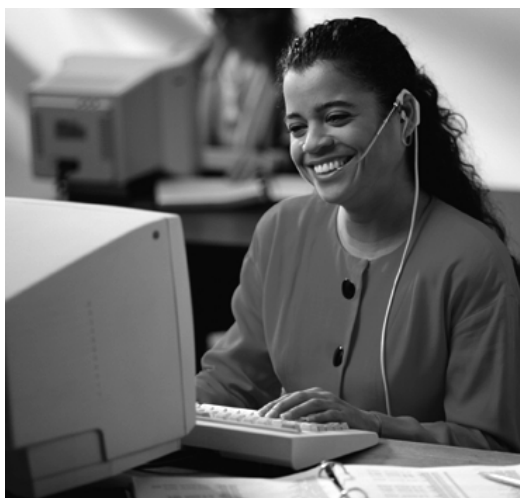


# Disability Law Center

### What is AT?

Many people with disabilities need some type of technology to be independent and participate in their community. This is called Assistive Technology or AT.

---

### AT can help you with:

- Talking and hearing
- Getting around your home and community
- Being able to take care of yourself
- Household chores



## Examples of AT

AT can be simple things like special forks and spoons and things to help you dress yourself, to complex things like talking computers and power wheelchairs.

---

### You may be able to get AT from:

- Medicaid and Medicare
  - Independent Living Centers
  - Vocational Rehabilitation
  - Special Education
  - Private Insurance

- Representing you in a legal hearing if you are denied AT
